4. First aid measures.

General:

In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.

Eye contact:

Remove contact lenses, irrigate copiously with clean, fresh water for least 10 minutes. holding the eyelids apart and seek medical advice.

5. Fire-fighting measures.

Extinguishing media: recommended: Alcohol resistant foam, CO², powders, water spray. Not to be used: Water jet.
